

REQUIREMENTS FOR RESIDENTIAL: MODULAR BUILDINGS

BEFORE BLDG. PERMIT CAN BE ISSUED:

- **IF MOVED IN MAIN STREET / HISTORIC DISTRICT SUBMIT PLANS TO PLANNING & ZONING FOR APPROVAL.**
 - IF BUILT IN SMART ZONE, APPLICANT MUST MEET WITH MAYOR FOR APPROVAL
 - PLAN REVIEW & APPROVAL BY (LIST OF INSPECTORS WIL BE FURNISHED TO YOU)
 - LICENSED ARCHITECT
 - LICENSED ENGINEER
 - LSUCCC INSPECTOR
 - LICENSED CONTRACTOR (CANNOT BE CONTRACTOR THAT IS BUILDING STRUCTURE)
- *INSPECTOR CANNOT BE IMMEDIATE FAMILY MEMBER OF APPLICANT**

-FURNISH CITY WITH CERTIFICATE OF PLAN REVIEW ALONG WITH STAMPED PLANS CERTIFYING COMPLIANCE (MUST BE SIGNED BY CERTIFIED INSPECTOR FROM LIST FURNISHED TO YOU)

-FURNISH CITY WITH CONDITIONS OF PERMIT FORM (SIGNED BY APPLICANT OF PERMIT)

- IF LOCATED IN FLOOD ZONE, CONTACT LICENSED ENGINEER FOR LETTER OF ELEVATION.

FURNISH CITY WITH COPY OF LA STATE CONTRACTORS LICENSE ON CONTRACTOR BUILDING STRUCTURE.

MANUFACTURER OF BUILDING MUST FURNISH CITY WITH A LETTTER OF COMPLIANCE THAT BUILDING HAS BEEN CONSTRUCTED IN ACCORDANCE WITH THE CURRENT ICC CODES.

-CULVERT PERMIT IS REQUIRED IF COVERING ANY DITCHES (Culvert applications available in permit dept)

THE FOLLOWING PERMITS MAY BE REQUIRED IF PROJECT IS LOCATED ON STATE HIGHWAY: LADOTD DRIVEWAY PERMIT AND/OR LADOTD PROJECT PERMIT (CONTACT LOCAL LADOTD OFFICE AT 893-5523)

BUILDING PERMIT CAN BE ISSUED ONCE ABOVE IS TAKEN CARE OF

NOTES: SEE BOUNDARY LINE REQUIREMENTS IN SEC 5-8 & 5-9 & BUILDING PERMIT REQUIREMENTS IN SEC 5-4 ATTACHED.

REQUIREMENTS FOR UTILITY CONNECTIONS:

LICENSED ELECTRICIAN & PLUMBER CAN PURCHASE PERMITS FOR ELECTRICITY, WATER & SEWERAGE CONNECTIONS & ARRANGEMENTS FOR CITY INSPECTIONS CAN BE MADE
***CALL PERMIT DEPT. FOR ELEC., WATER & SEWER INSPECTIONS AT 898-4213 OR 898-4212**

CONSTRUCTION ELECTRICITY CAN BE GIVEN AFTER ELECTRICAL PERMIT IS ISSUED.

INSPECTIONS REQUIRED ONCE CONSTRUCTION BEGINS:

FOUNDATION INSPECTION

OPEN WALL INSPECTION (IF APPLICABLE)

FINAL INSPECTION

ROOF INSPECTION (IF APPLICABLE)

(TO BE DONE BY CERTIFIED INSPECTOR WHO APPROVED PLANS)

MANUFACTURER OF BLDG. MUST FURNISH THE CITY WITH A LETTER OF COMPLIANCE THAT BLDG. HAD BEEN CONSTRUCTED IN ACCORDANCE WITH CURRENT CODES.

FINAL ELECTRICITY WILL NOT BE GIVEN UNTIL INSPECTIONS AND LETTER OF COMPLIANCE HAVE BEEN RECEIVED.
