Requirements before Demolition Permit is Issued

PLEASE NOTE THE FOLLOWING REQUIREMENTS THAT THE PROPERTY AND/OR BUILDING OWNER IS REQUIRED TO TAKE CARE OF **BEFORE A DEMOLITION PERMIT CAN BE ISSUED.**

- Contact the Permit Department to apply for a Demolition Permit. This department will co-ordinate Inspection by Public Works Department to meet with Applicant at demolition site to determine how City of Abbeville utilities (water, sewer, electricity and drainage) will be secured.
- Contact Louisiana One Call (1-800-272-3020) for utility locations.

Requirements once Demolition Permit is Issued

- All demolition debris must be removed from property
- Demolition debris cannot be placed on City Right-of-Way.
- Any contractor or business which is hired or retained to do or perform demolition work, is prohibited from placing demolition debris on or adjacent to city streets, and is required to transport the same to the Vermilion Parish Solid Waste facility(898-4338)
- All cement pillars, cement slabs, steps, piping, etc. must be removed from property.
- City of Abbeville utilities and drainage on property must be secured before demolition is started.
- Any tall grass, heavy brush or fallen trees must be cleared from property.

UPON COMPLETION OF DEMOLITION, PLEASE CONTACT THE CITY OF ABBEVILLE AT (337)898-4213 TO ARRANGE FOR INSPECTION OF SITE TO INSURE THAT THE ABOVE REQUIREMENTS HAVE BEEN COMPLIED WITH. FAILURE TO COMPLY MAY RESULT IN CHARGES BILLED TO OWNER IF CITY HAS TO COMPLETE ANY OF THE ABOVE REQUIREMENTS.
