TRAINING AND EXPERIENCE REQUIREMENTS (You must meet these requirements or you will not be allowed to take the examination.)

**Apprentice Line Worker 1:** One year of experience performing general labor or maintenance tasks, or substituting any combination of course work or training which demonstrates the ability to learn the trade. High School Diploma or GED required. Possession of valid driver's license required. **Apprentice Line Worker 2:** One year experience as an apprentice line worker or comparable position involving experience or training in high voltage electrical work and the ability to read, write, interpret diagrams, and perform basic mathematical calculations. High School Diploma or GED required. Possession of commercial driver's license prior to appointment.

#### **DUTIES**

This is semi-skilled work in helping linemen engaged in the installation, maintenance, and repair of transmission and distribution lines in the municipal electricity distribution system. Assignments are varied and provide broad experience and practical training leading to the development of lineman skills. Assists a line worker on the ground or in an aerial bucket to learn the installation, repair, and maintenance techniques of the electrical distribution trade. Observes safety rules and regulations.

## **NECESSSARY SPECIAL REQUIREMENT**

**Apprentice Line Worker 1:** Within the first year of employment the incumbent obtain and thereafter maintain the appropriate class commercial driver's license as required by the State of Louisiana to operate equipment with the assigned department.

**Apprentice Line Worker 2:** Possession of the appropriate class of commercial driver's license prior to appointment, as required by State of Louisiana. Possession of appropriate electrical license as administered by the City of Abbeville, within the first year of probational or permanent appointment.
