Mayor Piazza asked Councilman Wayne Landry to lead the assembly in prayer. Mayor Piazza asked Councilman Francis Touchet, Jr. to lead the assembly in the Pledge of Allegiance.

-01 introduced by Mr. Francis Plaisance and seconded by Mr. Francis Touchet, Jr. to approve the minutes from the Committee meeting held on July 11, 2017 and the regular City Council meeting held on July 18, 2017. The motion carried unanimously.

-02 introduced by Mr. Wayne Landry and seconded by Mr. Francis Touchet, Jr. to approve the probational appointment of Jacob Bergeron to the vacant position of Firefighter with the Abbeville Fire Department pending successful completion of all post-hire assessments. The motion carried unanimously.

-03 introduced by Mr. Francis Touchet, Jr. and seconded by Mr. Wayne Landry to approve the probational appointment of Jessica Sonnier to the vacant position Utility Collection Specialist in the Central Office pending successful completion of all post-hire assessments at a starting rate of \$10.00 per hour. The motion carried unanimously.

Mayor Piazza asked if there were any public comments on any agenda item prior to action. There were none.

-04 introduced by Mr. Francis Plaisance and seconded by Mr. Francis Touchet, Jr. to approve the estimate for dirt work and landscaping at Lafitte Drive-In Park at a cost of \$9,200.00. The motion carried unanimously.

Councilman Plaisance stated Josh Boudreaux would be completing this work. Mayor Piazza asked if he and the Committee could meet with Mr. Boudreaux prior to him beginning the work. Also, we would like him to start as soon as possible.

- -06 introduced by Mr. Wayne Landry and seconded by Mr. Brady Broussard, Jr. to approve the estimate from Capital Electric & Supply, LLC in the amount of \$7,529.00 for a new panel for the RV Park Sewer Lift Station. The motion carried unanimously.
- -07 introduced by Mr. Brady Broussard, Jr. and seconded by Mr. Wayne Landry to award the contract for the Construct Asphalt Taxiway project at the Abbeville Chris Crusta Memorial Airport to Elliott Construction in the amount of \$292,368.00 contingent upon FAA & DOTD approval. The motion carried unanimously.

Mayor Piazza stated he drove to Minden recently to tour their new airport terminal. It is almost identical to the one we will construct. We are in the final stages of planning.

- -09 introduced by Mr. Francis Plaisance and seconded by Mr. Brady Broussard, Jr. to award the contract for the Self-Contained Breathing Apparatuses (SCBA's) for the Abbeville Fire Department to Premier Fire Equipment, LLC in the amount of \$175,528.34. The motion carried unanimously.
- -10 introduced by Mr. Brady Broussard, Jr. and seconded by Mr. Francis Plaisance to approve the recommendation of the hearing officer for hearings held on July 26, 2017 for the following properties: 406 S. Lamar/ tall grass, dilapidated garage apartment/ given 15 days, 1732 Franks Alley/partially demolished structure/given 15 days, 605 ½ S. Louisiana/running generator for power to mobile home/given 30 days, 705 Hawthorne/grass/given 5 days, 1100 N. Airport Rd/tall grass, junk, vehicles/given 10 days, 800 Loraine/loose chickens/given 5 days and 703 S. St. Valerie/loose chickens/issued compliance certificate. The motion carried unanimously.

We are working to simplify the phone system and modernize it. We want to be able to forward

calls, track calls and give us some data on the number of incoming calls that are missed and returned. We are always looking at new technology at City Hall. It is good that we can afford those things and offer a better service for our customers. He will keep the Council posted on this.
