 - _____ Details indicating proposed billboard area, dimensions, colors, materials, graphic illustration and methods of illumination and attachment. Attach Graphic Illustration
 - _____ A site plan indication of the location of all existing and proposed billboard.
 - _____ Locations of setbacks
 - _____ Site Plan
 - _____ Photographs of the proposed sign location and the existing billboard.
- _____ Pay for license once billboard application has been approved.
- _____ Building Permits are required when erecting new billboards (Additional Fees May Apply)

PROGRAMMABLE BILLBOARDS ARE NOT ALLOWED

Billboards or signs with foundation and/or site requirements are subject to review by the City's Building Code Enforcement Office with Administrative Fees charged to cover to review.
