

## AFFIDAVIT CLAIMING EXEMPTION FROM LICENSURE

**Under penalty of perjury and the filing of false public records, the undersigned does hereby acknowledge and certify that all the information contained in the building permit application and provided herein is true and correct.**

\_\_\_\_\_ I understand that state law requires construction be done by a licensed contractor and I have applied for a permit under the exemption granted in La. R.S. 37:2157(A)(14), <https://legis.la.gov/Legis/Law.aspx?d=93576>, to act as the general contractor as defined in La. R.S. 2150.1(4), <https://legis.la.gov/Legis/Law.aspx?d=93567>, for the construction, repair, improvement, or maintenance of my home or accessory building and will maintain the house as my primary residence following the issuance of the Certificate of Occupancy or completion of construction.

\_\_\_\_\_ I understand that I will not be allowed to obtain a permit for the construction or improvement of another residence within a period of one year from the issuance of the Certificate of Occupancy unless I experience a change in legal marital status or employment as specified in La. R.S. 37:2157(A)(14).

\_\_\_\_\_ I understand that as the contractor of record, I bear sole legal and financial responsibility for the entirety of this project; must provide direct, onsite supervision of the construction; may not hire an unlicensed person to act as my contractor, construction manager, and/or to supervise persons working on my residence or building.

\_\_\_\_\_ I understand that it is a frequent practice of unlicensed persons to have the property owner obtain an owner-builder permit that erroneously implies that the property owner is providing his or her own labor and materials. I, as an owner-builder, may be held liable and subject to serious financial risk for any injuries sustained by an unlicensed person or his or her employees while working on my property. My homeowner's insurance policy may not provide coverage for those injuries. I am willfully acting as an owner-builder and am aware of the limits of my insurance coverage for injuries to workers on my property. I am aware of the recommended builder's risk, workers' compensation, and liability insurances I may purchase for protection from financial risk.

\_\_\_\_\_ I understand that I may protect myself from potential financial risk by hiring a licensed contractor and having the permit filed in his or her own name instead of my name.

\_\_\_\_\_ I agree that, as the party legally and financially responsible for this proposed construction activity, I will abide by all applicable laws and requirements and the construction itself must comply with all applicable laws, ordinances, building codes, and zoning regulations.

\_\_\_\_\_ **I understand that this exemption does not apply to any subcontractors who are subject to licensure requirements as described in La. R.S. 37:2150, *et seq.***

\_\_\_\_\_ I understand the warranty provisions of the New Home Warranty Act are found in La. R.S. 9:3141-3150. \_\_\_\_\_ I understand that this affidavit is the **only** document authorized by the Louisiana State Licensing Board for Contractors pursuant to La. R.S. 37:2160(C) to claim exemption from licensure.

\_\_\_\_\_ **I understand that the intentional act of submitting false information to a public agency is a felony violation under R.S. 14:133 of the Louisiana Criminal Code, punishable by up to five (5) years in prison and/or a fine of up to \$5,000.00.**
